In accordance with the requirements of Section 222.16 of the Canadian Aviation Regulations, Standards, the lessor and lessees hereby agree on the following terms:-

- 1. This lease shall become effective at 12:01 a.m. on the 1st day of MAY, 2019 and shall expire at 11:59 p.m. on the 30th day of NOVEMBER, 2021.
- 2. The lessor will not provide directly or indirectly any flight crew member to operate the aeroplane for the duration of the lease, i.e. this is a dry lease agreement and all pilots shall operate the aeroplane for their own private purposes.
- 3. The lease fee shall be fifty Canadian dollars (\$50.00 Cdn) per hour of aircraft use as recorded by the aircraft tachometer readings.
- 4. The lessor shall pay all costs associated with aircraft insurance, maintenance, engine overhaul, repairs, licencing fees, registration fees and all other costs of operation except for fuel, oil, landing fees and parking fees which shall be the responsibility of the lessees.
- 5. The lessees, as the operators and registered owners, shall have legal custody and control of the aeroplane, and shall be responsible for the airworthiness and maintenance of the aeroplane for the duration of the lease.

- 6. Fees shall be based on periods of one calendar month with payment to be made within 30 days of the end of each month.
- 7. The aeroplane shall be operated solely by the lessees or by licenced pilots who receive prior permission from a lessee.
- 8. The current extent of insurance coverage, in terms of benefits payable and risks covered, shall not be reduced in any way during the period of this lease.
- 9. This agreement may be terminated by the lessor or the lessees after giving fourteen (14) days written notice to the other party.
- 10. Every lessee is over the age of sixteen (16) years and is either a Canadian Citizen, a Landed Immigrant or a Canadian Resident in possession of a valid Permanent Resident Card.
- 11. This agreement shall not be amended or altered in any way except in writing executed by both parties.
- 12. Sub-leasing, or assignment of this agreement, is not permitted.
